- If you request electricity for your booth, we will run one extension cord into the booth. Any additional power cords or power strips would need to be supplied by you.
- Performers will be notified within two weeks after their application has been received as to which date(s) they have been assigned.
- Musical acts are expected to be set up and ready to perform by 10:00 am on the day(s) they are scheduled, and to play until the market closes at 1:00 pm (with breaks as needed).
- If you are unable to attend the market on the day you are scheduled to perform, you must notify Rob Lynch, the music coordinator, at least 24 hours in advance by calling or texting 978.437-7928. Failure to do so may result in cancellation of future performance dates for the 2023 season.
